Milk Price Gambling?

At lunch this week a friend jokingly told me "I keep hearing that risk management will be the salvation of the dairy industry and I'm not sure that I want to be gambling on my milk price." I'm certain this is a common concern of producers.

The goal of price risk management should be to cover your cost of production and protect profits, not to gamble that prices will improve.

The graph below shows the March 2010 Class III milk contract price has increased from \$13.46 to \$15.15 since the end of August. In the past year, March 2010 Class III milk has traded between \$13.41 and \$15.75. Will the milk price graph continue to increase?

What if the March 2010 graph dips again? Joe Dairyman could consider a Dairy LGM policy, a minimum price contract with his milk cooperative, or a Class III 'put' option purchased through his broker. These tools can set a price floor to protect a profitable milk price while allowing Joe the opportunity to receive the higher price in his milk check if prices do increase.

Is Joe gambling by using pricing tools to protect a profitable price, or is he gambling by simply hoping the milk price will be higher next spring?

Because of the Thanksgiving and Christmas holidays, LGM will be offered for sale on Nov. 20 & 21, 2009 and Dec. 18 & 19, 2009.

Prices change daily. This market information is an example for educational purposes. The market data below are compiled weekly by Farmshine, using CME and USDA reports and the CDE Scorecard.

Crop insurance notes: The harvest price has been set for CRC corn at \$3.72 and soybeans at \$9.66. If you think you have a claim, call your agent immediately. Claims may be denied if notice of loss is turned in after December 10, 2009. November 16, 2009 is the deadline to file acreage reports for fall seeded barley, wheat and APH forage production policies. GRP forage production insurance enrollment/policy change deadline for grass and legumes is November 30, 2009 for the 2010 crop year. As always, your questions and comments are welcomed.
